

ARTICULATION AGREEMENT

between

STATE UNIVERSITY OF NEW YORK  
COLLEGE OF AGRICULTURE AND TECHNOLOGY AT COBLESKILL  
and

ADIRONDACK CENTRAL SCHOOL

APRIL 2022 – APRIL 2027

The State University of New York College of Agriculture and Technology at Cobleskill and Adirondack Central School jointly endorse this articulation agreement impacting the graduates successfully completing the CASE Agricultural Business program. It is the intent of this agreement to recognize the breadth and depth of this program as a foundation for students who matriculate at SUNY Cobleskill in a Business, Food Service and Agricultural Management Department degree program. A candidate<sup>1</sup> from Adirondack Central School who:

1. Receives a New York State high school diploma
2. Follows the Adirondack Central School CASE Agricultural Business curriculum and achieves an 85 average or higher in each course included in the above curriculum and meets all other SUNY Cobleskill admission requirements for their major
3. Has a written recommendation from the Adirondack Central School CASE Agricultural Business program instructor

will be offered by SUNY College of Agriculture and Technology at Cobleskill:

1. Guaranteed admission into a Business, Food Service and Agricultural Management Department degree program, provided that the student meets admission requirements for the program and that there is availability within the program
2. Will receive 3 semester hours of advanced standing credit for SUNY Cobleskill's course AGBU 101 - Introduction to Agricultural Business

The student must complete and file a SUNY Cobleskill Admissions Application according to instructions. The letter of recommendation from the Adirondack Central School CASE Agricultural Business program instructor must accompany the application stating the student attends this institution, which has an articulation agreement with SUNY Cobleskill.


The effective date of this agreement is April 1, 2022, and will be reviewed for renewal, five years after signing, by the participating parties.

<sup>1</sup> Persons not meeting these criteria have the option of applying to SUNY Cobleskill under regular admission procedure.


