

ARTICULATION AGREEMENT

between

STATE UNIVERSITY OF NEW YORK
COLLEGE OF AGRICULTURE AND TECHNOLOGY AT COBLESKILL
and

GRANVILLE JR./SR. HIGH SCHOOL

APRIL 2022 – APRIL 2027

The State University of New York College of Agriculture and Technology at Cobleskill and Granville Jr./Sr. High School jointly endorse this articulation agreement impacting the graduates successfully completing the Animal Science program. It is the intent of this agreement to recognize the breadth and depth of this program as a foundation for students who matriculate at SUNY Cobleskill in a major within the Animal Science Department. A candidate¹ from Granville Jr./Sr. High School who:

1. Receives a New York State high school diploma
2. Follows the Granville Jr./Sr. High School Animal Science curriculum, achieving an 85 or higher average in each course included in the above curriculum and meets all other SUNY Cobleskill admission requirements for their major
3. Receives a written recommendation from the Animal Science instructor

will be offered by SUNY College of Agriculture and Technology at Cobleskill, Department of Animal Science:

1. Guaranteed admission into an Animal Science program, provided that the student meets admission requirements for the program and there is availability within the program.
2. Will receive advanced standing credits for SUNY Cobleskill's course ANSC 101 - Foundations of Animal Science (3 credits).
3. Will receive advanced standing credits for SUNY Cobleskill's course ANSC 111 Introduction to Animal Science (3 credits), after the student passes the challenge exam given during the first week of classes at SUNY Cobleskill.
4. Will receive advanced standing credit for SUNY Cobleskill's course ANSC - 140 Small Animal Management (3 credits), after the student passes the challenge exam given during the first week of classes at SUNY Cobleskill

The student must complete and file a SUNY Cobleskill Admissions Application according to instructions. The letter of recommendation from the Granville Jr./Sr. High School Animal Science instructor must accompany the application stating the student attends this institution, which has an articulation agreement with SUNY Cobleskill.


The effective date of this agreement is April 1, 2022, and will be reviewed for renewal, five years after signing, by the participating parties.

¹ Persons not meeting these criteria have the option of applying to SUNY Cobleskill under regular admission procedure.


